How To Earn Continual Learning Credits

Remember, continual learning credits are part of your annual certification requirements.

Any Official who was certified before November 1, 2023, will need to earn 4 continual learning credits in order to recertify for the 2024-25 certification cycle. The credits you earn must be split:

- 2 Credits in the Tennis Knowledge Library
- 2 Credits in the General Knowledge Library

Continual learning credits don't roll over from cycle to cycle. Once you earn the required number of credits for this certification cycle, you will not earn credit for any other learning experience you complete for the rest of the cycle

ProSteps for earning your continual learning credits!

- 1. OfficialsFirst My Certification Tab
 - a. The "Education Credits" section under Core Requirements will let you know how close you are to meeting your continual learning credit goal.

- 4. Click the "My Trainings" tab
 - a. This tab is your full learning history so that you don't retake content you have already completed. Remember, credit will not be earned on content you have completed in the past.
- 5. <u>Review the breakdown of credit earning for everything in the LRC</u>
 - a. This can be found on the <u>Officiating Certification Regulations</u> web page.
- 6. Find Content that will earn you credits → Click the "Home" Tab
 - a. Ways to Earn Continual Learning Credits in the Officiating Learning Resource Center
 - i. Disciplines and Courses section
 - 1. Courses earn 1 credit each
 - 2. Most of the short items in the Diversity & Inclusion library earn 0.25 credit.
 - ii. In-Person Education
 - 1. Workshops earn 2 credits
 - iii. Webinars
 - iv. Check out the "Webinar Recordings" library, the number of credits earned and if it counts towards general or tennis knowledge will be listed with the title.
 - b. Other Ways to Earn Continual Learning Credits
 - i. You can also earn Continual Learning Credits by:
 - Complete CPR/AED Awareness or Certification Training
 - Complete Courses offered by the Officiating Collective
 - Be Certified to Work in Another Sport

- 7. Check the "My Trainings" tab
 - a. Online courses and webinar recordings will show up immediately.
 - b. Workshops and live webinars attendance can take up to a week.
 - c. Once the completion shows up on your My Training tab, it takes 24 hours for your LRC Dashboard to update and can take up to 48 business hours for OfficialsFirst to update.
